The Representative of the Contracting Authority when performing actions pursuant to Act no. 134/2016 Coll., on the awarding of public contracts, as amended (hereinafter referred to as "*the Act*"), related to the awarding procedure of public contract is **KOUKAL LEGAL**, advokátní kancelář s.r.o.

Due to the fact that the request for an explanation of the procurement documentation, which is dealt with in this explanation, alteration or supplementation of documentation of the procurement procedure, was submitted in Czech, the Contracting Authority, in order to ensure broad competition, translated the submitted questions into the English (as the language in which procurement procedure is conducted) and provides answers to these questions in both Czech and English.

EXPLANATION, ALTERATION OR SUPPLEMENTATION OF TENDER DOCUMENTATION

The Contracting Authority explains, alters or supplements the documentation of the procurement procedure <u>based on the economic operator's request</u> according to Section 98 or 98 of the Act as follows:

Question No. 1

Bod 88 návrhu smlouvy. V minulosti bývala smluvní pokuta max 0.1%, nyní je 0.2% a navíc bez limitu, který bývá max 5-10% z celkové částky. Dodavatelé by uvítali úpravu v tomto duchu. Důvod nepřehledná situace ve světě může způsobit nečekané výpadky od subdodavatelů.

(Paragraph 88 of the draft purchase contract. In the past, the contractual penalty used to be a maximum of 0.1%, now it is 0.2% and, in addition, without a limit, which is usually a maximum of 5-10 % of the total amount. Suppliers would welcome an adjustment along these lines. The reason - the confusing situation in the world can cause unexpected outages from subcontractors. – the Contracting Authority's translation).

Answer

The Contracting Authority modifies the draft purchase contract by changing the contractual penalty from 0.2% to 0.1% in paragraph 88 of the draft purchase contract and adds that the value of this contractual penalty will not exceed 10% of the total price of the performance.

Question No. 2

(The warranty is usually 12 months, in the draft purchase contract there is the warranty 24 months. For this change, foreign companies demand a price increase, which increases the amount for the equipment compared to the original offers. Is it possible to set a warranty period of 12 months? - the Contracting Authority's translation).

Answer

The Contracting Authority modifies the draft purchase agreement by changing the warranty period from 24 months to 12 months.

Question No.3
