## II.

#### **Rationale:**

The Contracting Authority selected the economic operator, because its bid fulfilled all the conditions required by the Contracting authority in the Procurement documentation and also in the Act. The Contracting Authority also selected the economic operator because its bid was evaluated as the most economically advantageous bid. The evaluation and its result are described in the report on the evaluation of the bids that is an annex of this notice.

#### Outcome of the assessment of fulfilment of the conditions for participation:

The committee appointed by the Contracting authority for assessment of fulfilment of the conditions for participation concluded the following results about the conditions for participation in the Procurement Procedure stated by the Contracting authority in the Procurement Documentation:

- 1. The bid was written in the required language.
- 2. The bid meets the conditions for the content, form and means of submitting bids.
- 3. The economic operator met all the qualification criteria by submitting an original of the Affirmation on Technical Qualification Criteria of 05.08.2022 signed by authorised person. Detailed information are contained in the Report on the assessment which is the part of the procurement procedure documentation.
- 4. The Cover Bid Note includes details required by the Procurement documentation.
- 5. **The bid price** meets the requirements stated by the Contracting authority in the Article 4 of the Procurement documentation. According to the Section 113 (1) of the Act, the Committee has also assessed whether the bid price is abnormally low. The Committee has not found the bid price to be an abnormally low bid price.

## **Objections:**

The reasoned objections against the decision on the selection of the economic operator shall be communicated to the Contracting Authority within 15 days of receipt of the decision on the selection of the economic operator and notice of the selection of the economic operator. The objections shall feature the particulars set forth in Section 244 of the Act.
